

BYLAW NO. 42-2016
A BYLAW OF THE TOWN OF BRUDERHEIM
TO AMEND THE MUNICIPAL DEVELOPMENT PLAN BYLAW 15-2013 OF
THE TOWN OF BRUDERHEIM

WHEREAS the Municipal Government Act, R.S.A. 2000, as amended ("the Act") provides that a Municipal Council may amend its Municipal Development Plan Bylaw.

AND WHEREAS the Council of the Town of Bruderheim wishes to amend Bylaw 15-2013 the Municipal Development Plan as it affects certain lands.

NOW THEREFORE the Council of the Town of Bruderheim, duly assembled, enacts as follows:

1. That Map 2: Future Land Use Map is hereby amended by re-designating a portion of Pt. SE 5-56-20-W4 from Residential Use area to Industrial Use area and the Recreation/Open Space Use area, as per the attached **Schedule A**; and
2. That Map 5: Residential Phasing Map is amended to reflect the change in residential area within Pt. SE 5-56-20-W4, as per the attached **Schedule B**.

This Bylaw comes into full force and takes effect on the date of third and final reading.

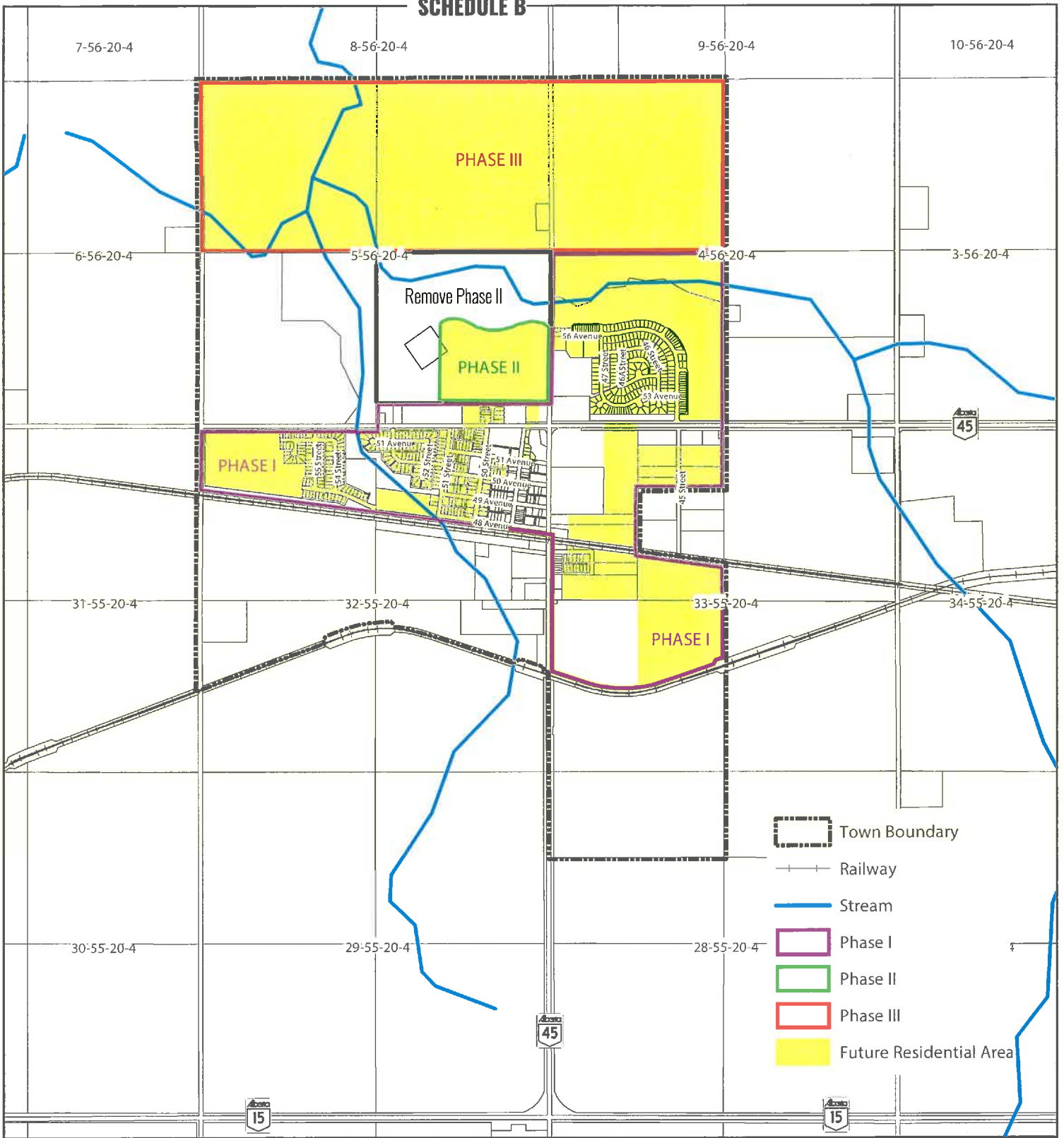
